The General Data Protection Regulation (GDPR) is a comprehensive data protection regulation that affects all organizations that process personal data of EU residents. It was adopted by the European Parliament and the Council of the European Union in April 2016 and became enforceable on May 25, 2018.

#### Who does the GDPR apply to?

- Companies
- Non-profit organizations
- Government agencies
- Self-employed individuals

The GDPR does not apply to the processing of personal data that is:

Processed by individuals for personal or household purposes

- Processed by competent authorities for the purposes of preventing, investigating, detecting or prosecuting criminal offenses
- Processed by national security or defense authorities

#### What is personal data?

Personal data is any information that relates to an identified or identifiable individual. This can include:

- Name
- Address
- Email address
- Phone number
- Social security number
- Credit card information
- Medical information
- Location data

Personal data can be collected in a variety of ways, including:

- Online forms
- Social media
- Email
- Phone calls
- In-person interactions

#### What are the key requirements of the GDPR?

The key requirements of the GDPR include:

- Transparency and fairness: Organizations must be transparent about how they collect and process personal data, and they must give individuals clear and concise information about their rights.
- Purpose limitation: Personal data can only be processed for the purposes for which it was collected. Organizations cannot process personal data for new purposes without the individual's explicit consent.
- Data minimization: Organizations should only collect and process the personal data that they need for the specific purposes for which it was collected.
- Accuracy and up-to-dateness: Organizations must take reasonable steps to ensure that the personal data they hold is accurate and up-todate.
- Security: Organizations must implement appropriate security measures to protect personal data from unauthorized access, use, disclosure, alteration or destruction.
- Accountability: Organizations are accountable for complying with the GDPR. They must be able to demonstrate how they are complying with the regulation.

#### How to implement and comply with the GDPR

There are a number of steps that organizations can take to implement and comply with the GDPR:

Conduct a data audit: Identify all of the personal data that


